Sub : Permanent affiliation upto B.Ed. Course from the Session 2011-12.

DECISION OF THE EXECUTIVE COUNCIL :

RESOLVED that the National Institute for Teacher Education, Khetri be granted Permanent affiliation upto B.Ed. Course from the Session 2011-12 on receipt of prior approval of NCTE.

The College be directed to fulfil the following conditions.

- (1) To obtain the approval of NCTE and submit the same to the University for necessary consideration.
- (2) The Librarian needs to undertake M.Lib.Course at the nearest future.
- (3) The number of library books requires to be increased. Annually large number of books needs to be purchased particularly subject and reference books. Books of upgraded edition needs to be issued of the students. More quality journals to be subscribed and on line journals to be subscribed.
- (4) The Library needs to be shifted to a large room having sitting capacity of minimum 60 students and Faculty members at a time the sitting arrangement requires to be comfortable and undisturbed during library studies.
- (5) The Psychology lab. Requires to be shifted to a large room with designed specification of furniture in the lab. The various instruments requires to be increased so that more students can use instruments in the lab.
- (6) The incomplete construction works to be speeded up for providing full facilities to the students.

RESOLVED also that the College be informed of the following conditions.

- (i) **Withdrawal of Affiliation** : The Executive Council on the Recommendation of the Affiliation Committee by a resolution shall have the power to withdraw any affiliation or permission from a College at any time. Whenever, if in the opinion of the Executive Council, the College has failed to comply with Statutes, Ordinance, Rules, Regulations or any other directives of the University or the College authorities have failed to maintain order and discipline in the College or the normal and proper functioning of the College has become impossible due to mismanagement of the affairs of the College or for any reason.
- (ii) The Annual fee of Rs. 4500/- (Rupees Four thousand five hundred) of the College be paid per year by the College.
